Participant Waiver, Release of Liability & Indemnification Agreement

I, the undersigned participant, acknowledge, agree and understand that:

1. Voluntarily and of my own free will, I elect to participate as a member of an outhouse racing team.
2. I understand that there are certain risks and hazards involved in participating in outhouse racing that may result in injury or death to me or other participants including, but not limited to those hazards associated with weather conditions, course conditions, equipment, and other participants.
3. I understand that pushing or pulling and riding in a moving outhouse is dangerous to me and may result in serious injury or death.
4. I understand that the very nature of this race is hazardous and risky, including, but not limited to, the acts of running, riding, pushing and pulling the outhouse, stretching, sliding, slipping, and collisions with spectators, participants or stationary objects, all of which can cause serious injury or death to me and to other racers.

Furthermore, I, the undersigned racer, agree that in consideration for the right to participate in this event and in consideration for permission to be on the course arranged by the race organizers:

1. I voluntarily elect to accept and assume all risks of injury incurred or suffered on my behalf (a) while spectating and participating in this event and (b) while on or upon the premises of the race course or grounds designated for this event.
2. I release, discharge and agree not to hold legally responsible the organization hosting said event, the property owner, lessee, and other entities associated with organizing this event, employees, or any person connected with this event for any claim, damages sustained or incurred by me from whatever cause including, but not limited to, the negligence, breach of contract or wrongful conduct of the parties hereby released.
